**Consult with Biointimo!**  
Official description of promotion

**1. Organizer of sweepstake**

“Consult with Biointimo!” –game, (hereinafter „Promotion”) is organized by the distributor of Biointimo products, Vitalinvest 2008 Ltd. ( seated at: H-1075, Budapest, Madách Trade Center, Madach I. u. 13-14., hereinafter: „Organizer”)

**2. Participation in the Promotion**

All natural persons possessing officially registered address in Hungary may apply for the sweepstake with the exception of owners, executive officers and personnel –including their next of kins- of Organiser and of all other companies and agencies taking part in liquidation of this sweepstake. (Hungarian Civil Code, 685.§ b) point). Owners, executive officers, personnel –including their next of kins as well- of all retail- and contractually obliged partners in regard to Organizer, who are executing their duties deriving from their contracts-in-issue in elapsing time period of Promotion. [Hungarian Civil Code, 385. § c) point], shall not participate either directly or indirectly in this Promotion.

**3. Products participating in Promotion**

Only and exclusively, **Biointimo DAY, Biointimo NIGHT, Biointimo EVERYDAY, Biointimo Menstrual Pain Sticker**, and also **Biointimo wet wipes called „LADIES”, „TRAVEL PACK”, and „SINGLE PACKAGES”** shall participate in this promotion that are available in Hungarian trade in the territory of Hungary.

**4. Period of Promotion**

Period of promotion lasts until the **midnight of December 31th 2011**.

Sweepstake of this actual promotion will take place on **Tuesday 14:00 PM January 3rd 2012**, in the seat of Organizer. **The following prizes will be sweptaken among the registered participants**

- ✓ **5 books of Dr. Oberkampf Mária: „Ájurvéda a mindennapokban” (Ayurveda in use)**

After the closure of Promotion takes place on **December 31st 2011**, no reguation of Promotion will be longer available. Participation in this actual Promotion neither is possible after the date of closure. All registrations administrated after the date of closure will be automatically taken as valid participation in the next sweepstake-game provided by Biointimo brand. Organizer is entitled to prolong the term this present game and widen the range of prizes of posteriorly. Organizer shall not create any regulations posteriorly trespassing upon, or derogating the rights of participants.

**5. Flow of Promotion**

**5.1. Process of Promotion**

For participation in this Promotion, all participants shall buy one of any type of Biointimo products in a reatil shop. After purchase, participants need to register at [www.biointimo.com](http://www.biointimo.com) by giving necessary data of name, address, e-mail address, and receipt number of purchase on the registration sheet. (e.g receipt number: 138/00137) Participant shall make up an own username on the registration sheet as well. By filling out the registration sheet, all participants agree with the conditions of this present description of Promotion,

and also accept the fact that they as registered users may get newsletters occasionally from Organizer to the e-mail address given by them at the registration.

One purchase receipt number shall participate only once in this Promotion, however one person may apply more times by more receipts attesting different purchases. Organizer regularly compares and controls all registered purchase receipt numbers. If a case of forgery becomes to be proven on the part of any winner, or it becomes proven that the winner has registered with a receipt not belonging to any Biointimo purchase, Organizer shall exclude such winner from the sweepstake game. In this case, a new participant is to be sweepstaken.

Organizer shall not be impeached in any way by any fact of false or forged data given by registered participants.

The prize offered in Promotion shall not be turned to as other donation or offering neither to as cash.

## **5.2 Receiving the Prizes**

- 5.2.1 Exact time of and other details of main prize **gynecological examination** shall be determined by the winner. Making an appointment for that shall be initiated by Istenhegyi Private Clinic by the contact information of winner given by the Organizer. Organizer shall inform the winner by e-mail in one week after the date of sweepstake at the email address given at registration. In case if winner does not reply either for two e-mails have been sent by the Organizer in two weeks after the sending time of the first e-mail by Organizer, winner will no longer have right for the prize and an other winner will be sweepstaken.
- 5.2.2 Regarding the **5 pieces of books of Dr. Oberkampf Mária: „Ájurvéda a mindennapokban” (Ayurveda in use)**, Organizer shall also inform the 5 winners in one week after the sweepstake by e-mail. Winners shall confirm the postal mail address for the Organizer in a reply. Prize books shall be shipped by a postal mail to the confirmed addresses of each 5 winners in two weeks from the date of first informational email sent by the Organizer. In case if winner does not reply either of two e-mails have been sent by the Organizer in two weeks after the sending time of the first e-mail, winner will no longer have the right for the prize and an other winner will be sweepstaken.
- 5.2.3 The **20 pieces of BIOINTIMO present packages** will be sent out as a postal mail to the addresses of the winners given at the registration sheet. Successful reception is the responsibility of the winners, Organizer shall not be liable either for any turned back packages, or for the quality of the services of Hungarian Post Service in general. If a package is not received and turned back to Organizer, it will not be send or sweepstaken again.
- 5.2.4 Organizer **will post the list of all winners** on biointimo webpage for two weeks after the sweepstake.
- 5.2.5 In case if fact of fraud about a winner registered with a forged or false purchase number becomes proven, Organizer has the right to exclude the winner from the game and also to delete him/her from the newsletter database as well. If this action takes place, another participant will be sweepstaken as a winner
- 5.2.6 Organizer shall not be impeached in any way by any fact of false or forged data given by registered participants.

## **6 Personal income tax**

Organizer undertakes to pay all taxes and affixes directly emerging relevantly to the prizes. All other possible affixes, taxes and costs indirectly emerging in regard to the prizes shall be covered by the winner.

## **7 Data Management**

- 7.1 The purpose of data management is measuring general customer satisfaction about the brand of Biointimo, managing customer care matters, and also forwarding direct offers of Biointimo to the registered users. Participant accepting this present description of Promotion states that he/she understands the purpose of data management, and by this acceptance he/she expressly agrees with recording, managing, and processing of his/her registered data by the Organizer, or by any other assigned data manager organizations charged by the Organizer. Participant also agrees with forwarding his/her data to assigned direct marketing agencies or market researchers as well in regard to cooperation in successful customer care, and measurement of customer satisfaction. All participants in Promotion shall get all information about the data management in regard to their own data, and shall ask for data correction, or deletion through e-mail address: [info@biointimo.hu](mailto:info@biointimo.hu) or through postal mailing to the official seat of Organizer (13-14. Madách I. rd., Budapest, H-1075) All data managers shall undertake to record, to manage, and to process data fully and comprehensively in accordance with regulations of statute LXIII. 1992. about safety of personal and publicity of public data, and also they are liable for eligible data management exclusively carried out in regard to those matters which participants gave their acceptance for.

7.2 Participant accepts that signing the square besides the sentence „I have read the regulation and I agree.” –means that he/she has read and understood all the regulations of this present description, and also he/she accepts all the rights and obligations deriving from it in regard to him/her. Signing the square besides the sentence also means, that participant agrees with entering into this Promotion by only his/her own deliberation, and on only his/her own responsibility, and also that he/she is being obliged by this present regulation. Furthermore, Participant undertakes to acquit Organizer of all damages deriving from falsely given or forged data.

## **8 Other provisions**

- 8.1 There is no deriving liability of owners, executive officers, and employees of Organizer in regard to any technological failure or any misfunctions of the prize, with the exception of expressive prohibition of excluding liability by Hungarian law.
- 8.2 There is no any other prize devided and handed out by the Organizer than the prizes posted on the webpage [www.biointimo.com](http://www.biointimo.com) defined in this present description.
- 8.3 There is no deriving liability of Organizer, either of retail shops or resellers –including the owners, executive officers, and employees of them- in regard to printing errors of promotion packages.
- 8.4 Packages provided with forged or false promotion stickers or manipulated surface shall be excluded from the game. Regarding all debates deriving about examination of genuinness of stickers and packages, Organizer shall make a final and accepted decision. There is no deriving liability of Organizer in regard to any debate based upon promotion stickers.
- 8.5 The prizes of this promotion shall not be withdrawn into trade or any commercial activity, and shall not be a part of any further sales promotion.

All failures, and misfunctions deriving from using the webside (including softwer and hardware failures or loosing data as well occuring either on the side of the user or of the operator) shall not found any case to damages based upon responsibility of either the Organizer or the webdeveloper. Organizer and webdeveloper shall not be impeached in any ways in the upper mentioned cases.
- 8.9 All participants by acception of this present description recognize that they shall not have a right to initiate a legal remedy regarding any possible demands relevantly to this Promotion.
- 8.10 Organizer shall not be charged regarding dead e-mails that were turned back could't be delivered.
